



**FAKE BAKE® Spray Tan Consent Form**

I hereby authorize Kingwood Skin Essentials or any delegated associates to perform an Airbrush Spray Tan. I understand that although airbrush spray tans are successful, results do vary by Client and cannot be guaranteed. \_\_\_\_\_ (Initials)

I am aware of the following:

- An airbrush tan, like any self tanning product will not protect your skin from burning in the natural sun or in a UV tanning bed.
- Maintaining your color is possible with subsequent visits every five to ten days. Healthy, hydrated skin will hold results longer and achieve results faster.
- For best results wait eight hours after airbrushing before showering.
- The initial bronzers in the airbrush tanning solution may transfer to clothing or fabric. The bronzers are water-soluble and will wash out of most fabrics.
- All the components of the airbrush tanning solution have been safely used in cosmetics and nutritional products for decades and have been proven safe for the skin. If you have had adverse effects utilizing self tanning products or moisturizers in the past, you may experience similar effects with the airbrush system. I agree to discuss this with the technician before proceeding.
- We recommend that you hold your breath during facial spraying. We make this recommendation because most individuals would prefer not to breathe the mist. The solution is not considered harmful in the minimal amounts that may be inhaled in a normal spray tanning session. If you have a history of asthma or other respiratory or medical condition that could be aggravated by the use of the airbrush systems, please consult a physician before proceeding. Please inform your tanning technician of any past allergic reactions to DHA products or other medical concerns.
- The airbrush spray tan should not be administered during pregnancy.

For women of childbearing age: By signing below I indicate that I am not pregnant. Furthermore, I agree to keep Dr. Browning, Kingwood Skin Essentials Med Spa and designated staff informed should I become pregnant during the course of treatment.
